In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

Closing Date for Entries: Wednesday, November 18, 2015, 12:00 p.m. after which time entries cannot be accepted, canceled, altered, or substituted.

Entry Fee: \$35.00 (includes \$.50 AKC Registration recording fee & \$3.00 event fee) for first entry. Puppy Class, Bred-By-Exhibitor, \$30.00. 12-18 month classes are adults for entry fee purposes.

Fax Entries: 877-667-4304. Both sides of the entry form must be faxed. Visa/Master Card number and expiration date, as well as the printed cardholder's name must be included. Fax entries must be received by the closing hour and date. Fax fee: \$4.00 per entry in addition to entry fee.

Telephone, telegraph and unsigned entries **CANNOT** be accepted.

Entry fee shall not be refunded in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred. Canadian exhibitors must make fees payable in US funds.

Entries not on Official AKC Entry Forms and photocopies of the entry without the Agreement and Rules from the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE.**

Errors on Entry Blanks: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

A recording fee of 50 cents and an event fee of \$3.00 will be required for each dog entered at any licensed or Member Club, Show, Obedience Trial, or Tracking Test. This fee is to be collected by the Show-giving Club and paid to AKC. If a dog is entered in more than one class in the show, the fee is collected on the first entry only. (American Kennel Club Rule, Chapter 14, Section 2)

All dogs must be held on leash except when in the exercise area or crated.

Grooming is indoors. Exhibitors are responsible for clean conditions in and around their crates and grooming areas.

Judges will not wait for any dog holding up a class.

No entry shall be made or accepted which specifies any condition as to its acceptance.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Judging schedule and map to the show site will be mailed as soon as possible after the closing of entries.

If an entry in the regular puppy classes is awarded Best of Breed or Best of Winners it will automatically be Best Puppy.

There will be a holding area set up outside of each ring that can be utilized during your judging. This area must be vacated as soon as judging is over. NOTE: All Rules and Regulations used during the Saturday & Sunday shows are applicable to the shows on Friday.

From the Orlando International Airport (EAST) 25 minutes

1. Go west on SR 528 to exit 1 (International Drive)
2. Go north (right) approximately one mile to Convention Center
3. The North/South Building parking lot can be accessed by turning right at the South Concourse sign or continuing north on International Drive and turning right onto Convention Way and following to Universal Boulevard, turn right onto Universal Boulevard.

From Daytona Beach or Downtown Orlando (NORTHEAST)

1. Take Interstate 4 west to the SR 528 exit (Exit 72)
2. Travel east on SR 528 to exit 1 (International Drive)
3. North (right) approximately one mile to Convention Center
4. The North/South Building parking lot can be accessed by turning right at the South Concourse sign or continuing north on International Drive and turning right onto Convention Way and following to Universal Boulevard, turn right onto Universal Boulevard.

From Gainesville, Florida (NORTHWEST) 2 hours

1. Take Interstate 75 south to Florida's Turnpike
2. Go south on Florida's Turnpike to Interstate 4 west
3. Go west on Interstate 4 to the SR 528 exit (Exit 72)
4. Go east on SR 528 to exit 1 (International Drive)
5. Go north (right) approximately one mile to Convention Center
6. The North/South Building parking lot can be accessed by turning right at the South Concourse sign or continuing north on International Drive and turning right onto Convention Way and following to Universal Boulevard, turn right onto Universal Boulevard.
